

The purpose of this modification is to provide incremental funding in the amount of **\$4,403,740.00**, thereby increasing the obligated amount of the task order from \$44,604,880.82 to **\$49,008,620.82**;

Accordingly, the following section of the task order is hereby modified:

1. Under Subsection B.8 CONSIDERATION AND OBLIGATION, the first sentence of paragraph (b) is DELETED entirely and REPLACED with the following:

"(b) The amount presently obligated with respect to this task order is **\$49,008,620.82**."
