On December 19, 2005, a telephone conference was held between U.S. Nuclear Regulatory Commission (NRC), ICF Consulting (contractor to NRC), Department of Energy (DOE), LMI (contractor to DOE), and USEC Inc. (USEC) staffs to discuss the need for DOE to develop and provide USEC a cost estimate and supporting basis for dispositioning the depleted uranium that USEC would generate at its proposed American Centrifuge Plant (ACP) over an operational period of 30 years.
