


The purpose of this modification is to 1) exercise Option Year 3 subject to the availability of funds pursuant to FAR clause 52.232-18 Availability of Funds stated in Section C.21 of the subject contract, and 2) add key personnel under Section C.18. Accordingly the contract is modified as follows:

1) As a result of exercising Option Year 3, the period of performance is revised as follows:

"The period of performance is from 12/01/2002 to 11/30/2006. There are two additional option years remaining under this contract."

2) Under Section B.1, the ceiling amount for the basic services is increased by \$2,892,577.50 from \$8,364,596.70 to \$11,257,174.20.

3) Under Section B.2, the estimated ceiling amount for additional guard services for Option Year 3 in the amount of \$17,104.50 is incorporated should the hours be necessary.

4) Section C.18, paragraph a., Key Personnel is hereby revised to include the following individual:

The contractor agrees that personnel may not be removed from the contract work or replaced without compliance with paragraphs (b) and (c) of Section C.18.

Additional funds are not provided at this time.
