The purpose of this modification is to allow two (2) Artel, Inc. employees to travel to Las Vegas, Nevada during the period of 11/7/2005 - 11/10/2005 (4 days and 3 nights) to perform scans of the Digital Data Management System (DDMS) developed by the Atomic Safety Licensing Board Panel (ASLBP) in support of the upcoming High Level Waste hearings. As part of the process to obtain full certification and accreditation of the DDMS, Artel Inc. will perform required device scans (i.e. firewalls, routers, etc.), and identify any security issues. Per your email dated 10/12/2005 to the NRC Project Officer, travel is estimated as follows: Airfare - Hotel - Car Rental - Meals & Inc Expenses (MI&E) - Local Mileage - and Airport Parking - \$2,307.00* This modification also provides funds in the amount of \$2,307.00 for the above travel requirements, thereby increasing the ceiling and obligated amounts of the order from \$165,022.00 to \$167,329.00.

*Travel reimbursement will be made in accordance with Federal Travel Regulations.
