Teleconference on the License Renewal Process

On December 20, 2005, the staff conducted a public teleconference/meeting on the license renewal process with the Nuclear Energy Institute, representatives of the industry, and the media. The meeting discussed lessons learned from the audit review process, license renewal process improvements, and development of a potential Interim Staff Guidance position on BWR Mark I containments. These monthly teleconferences help ensure continued effective communication with the industry and the public on the latest license renewal experience and potential future improvements in the license renewal process.

Seabrook Measurement Uncertainty Recapture (MUR) Power Uprate Meeting

On December 16, 2005, the staff met with FPL Energy, LLC, to discuss its MUR power uprate license amendment request. The purpose of this meeting was to discuss various areas of concern with ultrasonic flow measurement (UFM) technology that were provided to the licensee in a letter dated November 30, 2005. The licensee was supported by representatives from Caldon Incorporated, the vendor for the UFM technology proposed for use at Seabrook. Currently, the staff is planning to attend the calibration and testing of Seabrook's UFM at Alden labs the week of January 16, 2006. The staff plans to issue requests for additional information to the licensee in January 2006. No members of the public attended the meeting.

Louisiana Energy Services (LES) Management Meeting

On December 20, 2005, staff from Region II, the Office of the General Counsel, and NMSS met with management from LES to discuss issues related to the proposed uranium enrichment facility to be located in Eunice, NM. Issues discussed included the status of the licensing review, hearings, and key milestones for regulatory submittals.

Staff Observes Department of Energy (DOE) Audit of the Bechtel SAIC Company, LLC (BSC) Corrective Action Program (CAP)

On December 12-20, 2005, NRC and Center for Nuclear Waste Regulatory Analyses (CNWRA) staff observed the DOE Office of Radioactive Waste Management (OCRWM) Office of Quality Assurance audit of BSC conducted at the BSC facilities in Las Vegas, NV. The purpose of this audit was to evaluate the adequacy, implementation, and effectiveness of CAP-related requirements and activities. The NRC and CNWRA observers assessed the effectiveness of the DOE audit team and the audit process in achieving the audit objectives.

Environmental Protection Agency (EPA) Decommissioning Consultation

On December 5, 2005, staff from the Division of Waste Management and Environmental Protection met with EPA staff to discuss the EPA response to NRC's letter dated October 18, 2005, regarding the Kerr McGee-Cushing site in Cushing, OK. NRC's letter notified EPA that the residual concentration levels in groundwater for total uranium exceed EPA's Maximum Contaminant Level, and requested a consultation between the two agencies, in accordance with the 2002 Memorandum of Understanding (MOU), "Consultation and Finality on Decommissioning and Decontamination of Contaminated Sites." In a letter to NRC dated December 13, 2005, EPA stated that it reviewed the information provided in the NRC letter and is satisfied with how NRC addressed the issues raised for this consultation. This is the first formal consultation between the two agencies under the MOU. It was considered a Level 2 consultation because it concerned radioactive contamination remaining after completion of the Final Status Survey.

Participation in the International Atomic Energy Agency (IAEA) Transport Safety Appraisal Service (TranSAS) Mission to Japan

On December 2-16, 2005, a staff member from the Spent Fuel Project Office participated in the subject mission. The objective of a TranSAS mission is to assist a country in achieving a high level of safety in the transport of radioactive material. This is achieved by reviewing the implementation of the IAEA Transport Regulations (TS-R-1) and making recommendations for improvement. The TranSAS mission to Japan was the seventh mission IAEA has conducted since the program was initiated in 1998. The thirteen-member IAEA team was composed of independent experts from member countries and IAEA staff members and consultants. In Tokyo, the team interviewed officials from the government agencies that regulate transportation of radioactive material in Japan. In addition, the team conducted visits to the Narita airport air

cargo areas, a nuclear power plant, a nuclear fuel fabrication facility, and emergency response facilities in the Tokai area. IAEA will prepare a final report on the TransSAS mission to Japan.

Proposed Rule on the Use of Electronic Submissions in Agency Hearings (AH74 - Parts 1, 2, 13, and 110)

On December 16, 2005, the NRC published a proposed rule in the Federal Register (70 FR 74950) that would require the use of electronic submissions in all agency hearings except for those conducted on a high-level waste repository application. The proposed rule builds on prior NRC rules and developments in the Federal courts regarding the use of electronic submissions. The comment period for this action closes March 1, 2006.

Denial of Petition for Rulemaking (PRM-50-79) from Mr. Lawrence T. Christian, et al.

On December 19, 2005, the NRC published a notice in the Federal Register (70 FR 75085) that denied the subject petition for rulemaking. The petition requested that the NRC amend its regulations regarding offsite state and local government emergency plans for nuclear power plants to ensure that all daycare centers and nursery schools in the vicinity of nuclear power facilities are properly protected in the event of a radiological emergency. The NRC denied the petition because current NRC and Federal Emergency Management Agency regulations and guidance already require the inclusion of daycare centers and nursery schools in state and local government offsite emergency plans.

Receipt of Petition for Rulemaking (PRM-31-5) from the Organization of Agreement States

On December 20, 2005, the NRC published a notice in the Federal Register (70 FR 75423) announcing the receipt of the subject petition for rulemaking. The petitioner requests that the NRC amend its regulations to require specific licenses for devices that are currently regulated by a combination of general licensing and registration. The petitioner also requests that the compatibility category for 10 CFR 31.6 be revised from "B" to "C." The petitioner believes that these actions are needed to establish a higher national standard of regulation for higher risk generally licensed devices. This document also requests public comment on a State of Florida request that the NRC change the compatibility category of 10 CFR 31.5 (c)(13)(i) from "B" to "C." The comment period for this action closes March 6, 2006.

Receipt of Petition for Rulemaking (PRM-35-18) from Peter G. Crane

On December 21, 2005, the NRC published a notice in the Federal Register (70 FR 75752) announcing the receipt of the subject petition for rulemaking. The petitioner requests that the NRC amend its regulations governing the release of individuals who have been treated with radiopharmaceuticals for medical purposes. The petitioner requests that the patient release rule be partially revoked so that patients would not be released from radioactive isolation with more than the equivalent of 30 millicuries of radioactive iodine I-131 in their bodies. The comment period for this action closes March 6, 2006.
