- Significant reduction in the effectiveness of a package during use;
- Defect with a safety significance;
- Shipment in which conditions of the approval were not observed.

2. What is the safety significance? High Medium Low

3. Summary of the report:

On September 12, 2005, Framatome ANP (FANP) noted one of the as-fabricated RAJ-II packages had a missing fillet weld on the cover mounting boss. An inspection completed on October 28, 2005, found a total of 8 packages with missing or under-length fillet welds and missing seal welds on their respective cover mounting bosses. At the time of the inspection the packages were not in service.

4. Corrective actions taken by the licensee:

At the time of inspection, the RAJ-II packages were not in service. Columbiana Hi Tech, LLC (CHT), the original package owner reworked the missing or under-length fillet welds and missing seal welds on the cover mounting boss the week of October 31, 2005.

CHT has upgraded their staffing and inspection protocols to address the weld deficiencies.
