Transfer of Control Application

In accordance with the requirements of NUREG 1556, Vol. 2, MISTRAS Holdings Group submits the following information applicable to Appendix E: Information Needed for Transfer of Control Application effective December 31, 2005

1. The new name of the licensed organization will be ***MISTRAS Holdings Group (MISTRAS), d/b/a CONAM Inspection & Engineering Services, Inc. , QSL Plus, CODE Services.***
2. The ***Code Services*** contact and telephone number(s) ***will remain the same.***
3. ***The officers of the controlling corporation are Sotirios Vahaviolos, Chairman, Michael Lange, CEO, Dennis Bertolotti, President. along with Scott Kvasnicka, Corporate Radiation Safety Officer, & Robert J Slack, Director of Regulatory Affairs.***
4. ***The transferor will remain in both licensed & non-licensed business.***
5. ***Pursuant to an Asset Purchase agreement, MISTRAS Holdings Group shall acquire Code Services, Inc. non-destructive testing business in which the licenses are used.***
6. ***There are no planned changes in organization, location, facility, or equipment. Any procedural changes will be through a merging of the O & E practices and will be equal to or more stringent than those existing for Code Services.***

8. ***Same as #6***
9. ***All surveillance items and records (e.g., calibrations, leak tests, surveys, inventories, and accountability requirements) will be current at the time of transfer. A description of the status of surveillance requirements is as follows:***
 - ***Leak tests –6 months***
 - ***Depleted Uranium Camera Tests – Annually***
 - ***Periodic Device Maintenance – 3 months (Quarterly)***
 - ***Personnel Periodic Audits 6 months***
 - ***Survey Meter Calibration –6 months***
 - ***Dosimetry and Alarming Rate Meter Verification – Annually***
 - ***Source/Device Inventory - Quarterly***
10. ***All applicable records concerning the safe and effective decommissioning of the facility, pursuant to 10 CFR 30.35(g), 40.36(f), 70.25(g), and 72.30(d); public dose; and waste disposal by release to sewers, incineration, radioactive material spills, and on-site burials, have been transferred to the new licensee and will remain at the current licensed locations. There will be no termination of business at any of the licensed locations. Code Services will be added to MISTRAS Holdings Group NRC license (12-16559-02) by amendment and their current license (16-31010-01) will be terminated with the issuance of said amendment.***
11. ***All licensed facilities will remain viable, named facilities. There will be no change of status.***
12. ***All licensed facilities will remain viable, named facilities. There will be no change of status.***
13. ***MISTRAS agrees to abide by all commitments and representations previously made to NRC by the transferor. As regards open inspection items. the***

transferee confirms that it accepts full responsibility for open action items and/or any resulting enforcement actions.

- 14. *MISTRAS and Code Services agree to transferring control of the licensed material and activities. Upon completion of the sale, all activities for the licensed materials will be transferred to MISTRAS. Code Service verifies it has made MISTRAS aware of all open inspection items and its responsibility for possible enforcement actions.*
- 15. *MISTRAS agrees to abide by all constraints, conditions, requirements, representations, and commitments identified in the existing license*
