- 1. Describe the training Dr. Kuehl has received in the following areas:
 - a. radiation protection principles
 - b. characteristics of ionizing radiation
 - c. units of radiation dose and quantities
 - d. biological hazards of exposure to radiation
 - e. radiation detection instrumentation.
- 2. Describe the specific isotopes Dr. Kuehl has handled, the maximum quantities of materials handled, where the experience was gained, the duration of the experience and the type of use
