3) Transportation and Route Schedule

The vessel sailed from Hamburg, Germany on September 27, 2005. The ocean transportation from Hamburg, Germany to Toronto, Ontario, Canada will be the responsibility of CANMAR Steamship Line. The vessel will unload at Montreal, Quebec, Canada on or about October 5, 2005. The containers will then transport by rail to Toronto, ON. The containers will enter the USA by road at Port Huron, MI between approx. October 31, 2005 and November 29, 2005 and continue on to Metropolis, IL. The inland transportation from Toronto ON to Metropolis, IL will be the responsibility of RSB Logistic Services Inc.
