Duke Cogema Stone & Webster (DCS) hereby submits Revision 4, Change 1 of the MOX Project Quality Assurance Plan (MPQAP) for design, construction, and operation of the MOX Fuel Fabrication Facility and related project activities. This Revision 4, Change 1 updates the organization in Revision 4, previously submitted to the NRC via Reference 3.


The enclosed document updates and, upon its effective date, will supersede Revision 3, provided in Reference 1. Revision 4 reformats large sections of the document to clearly delineate the requirements and extends the scope to include startup and operation of the MOX Fuel Fabrication Facility. A description of the changes in Revision 4, Change 1 relative to Revision 4 is contained immediately following the Table of Contents. That change description is followed by the description of the changes in Revision 4 relative to Revision 3. DCS has reviewed these changes and determined there is no reduction in commitments for the design and construction activities; therefore, DCS has assigned an effective date of 31 January 2006 for this revision.

The revised MPQAP is enclosed. For your convenience, we also have enclosed a disk containing an electronic copy of the Plan (compiled in Adobe Acrobat format).
