Inova Fair Oaks Hospital would like to request changes to our NRC license.

The contract for the current professional corporation of radiologists (Association of Alexandria Radiologists) expires on March 1, 2006. On that date a new professional corporation of radiologists (Fairfax Radiology Consultants, Inc.) will begin working at Inova Fair Oaks Hospital.

Because of this change, the Radiation Safety Officer and all Authorized Users on the NRC license will require changing.

Inova Fair Oaks Hospital would like to request the following amendments to our NRC license (*This change should be effective on January 1, 2006 to assist with the transition*):

- (1) Deletion of Michael Weiss, M.D., as Radiation Safety Officer
- (2) Appointment of Michael Taylor as the new Radiation Safety Officer

Michael Taylor is currently listed as an Authorized Medical Physicist on the NRC license for Inova Fairfax Hospital (NRC license #45-17128-01), and has been appointed as Radiation Safety Officer for a number of naval facilities during his career as a Naval Officer (documentation attached). Mr. Taylor meets the requirements of 10 CFR 35.900 by being certified by the American Board of Medical Physics in radiation oncology physics (documentation attached). Mr. Taylor was also the temporary RSO at Inova Fairfax Hospital from December 2002 until March 2003 when their RSO took a leave of absence.


