SUBJECT: REQUEST FOR AN EXTENSION OF TIME TO RESPOND TO ORDERS

Dear Ms. Penney:

This refers to your letter dated January 19, 2006, in response to the immediately effective Orders prohibiting involvement in Nuclear Regulatory Commission (NRC)-licensed activities issued by the NRC to Mr. Dale Miller and Mr. Steven Moffitt on January 4, 2006. Your letter requested an extension of time to respond to the Orders.

We have reviewed your request for an extension to the response times included in the Orders to Mr. Miller and Mr. Moffitt and determined that you provided good cause for the requested extension. On January 20, 2006, Sara Brock from the NRC Office of the General Counsel provided you with my verbal approval of your request. In accordance with Section VI of the Orders, I am granting your extension request for an additional 30 days to answer the Orders and request a hearing on the Orders. Please provide your responses by February 23, 2006. Please note that although we have extended your time to respond to the Orders, the Orders are immediately effective, and thus remains in effect.
