This refers to your letter dated January 18, 2006, in response to the immediately effective Order prohibiting involvement in Nuclear Regulatory Commission (NRC)-licensed activities issued by the NRC to Mr. Prasoon Goyal on January 4, 2006. Your letter requested a six month continuance to respond to the Order.

We have reviewed your request for an extension to the response times included in the Order to Mr. Goyal and determined that you provided good cause for the requested extension. In accordance with Section VI of the Order, I am granting your extension request for an additional six months to answer the Order and request a hearing on the Order. Please provide your response by July 6, 2006. Please note that although we have extended your time to respond to the Order, the Order is immediately effective, and thus remains in effect.
