3) Transportation and Route Schedule

The vessel will sail from Hamburg, Germany on June 2, 2002. The ocean transportation from Hamburg, Germany to Montreal, Quebec, Canada will be the responsibility of CANMAR Steamship Line. The vessel will unload at Montreal, Quebec, Canada on or about June 10, 2002. The containers will then be loaded onto the rail for importation to Detroit, MI.
