# SUBJECT: COMPLETION OF ACTIONS SET FORTH IN CONFIRMATORY ORDER

Dear Mr. Probasco:

The purpose of this letter is to acknowledge receipt of your letter dated October 22, 2005, in which you documented completion of actions you were required to perform in accordance with the Letter of Reprimand and Confirmatory Order Modifying License issued to you by the U.S. Nuclear Regulatory Commission (NRC) on July 14, 2005. Those actions consisted of participating in future training sessions at Pilgrim, submitting a letter with your lessons-learned to the "Communicator" (a publication of the Professional Reactor Operator Society), and making a presentation at a future meeting of the Professional Reactor Operator Society (if invited).

The NRC reviewed completion of your actions during an inspection conducted at Pilgrim between October 24 through October 26, 2005, the results of which are described in NRC Inspection Report No. 05000293/2005005. The inspectors reviewed your letter dated October 22, 2005, interviewed a sample of licensee personnel, and reviewed training documents and attendance records to verify that the corrective actions were taken and completed as described. Region I also verified that you had submitted an article for inclusion into an upcoming issue of the "Communicator" and that you have been invited to make a presentation at a future meeting of the Professional Reactor Operator Society. Once you have completed the remaining action (i.e., making a presentation at the Professional Reactor Operator Society since you were invited), please notify us in writing within 30 days.

A copy of this letter and your response dated October 22, 2005, will be made available electronically for public inspection in the NRC Public Document Room or from the NRC's document system (ADAMS). ADAMS is accessible from the NRC Web site at <u>http://www.nrc.gov/reading-rm/adams.html</u>. These letters will be maintained by the Office of Enforcement (OE) in a NRC Privacy Act system of records, NRC-3, "Enforcement Actions Against Individuals."
