Public Workshop on a Draft Grid Reliability Generic Letter

On January 9-10, 2006, the staff held a public workshop with the Federal Energy Regulatory Commission (FERC), the North American Electric Reliability Council (NERC), the Nuclear Energy Institute (NEI), the Institute of Nuclear Power Operations (INPO), the Electric Power Research Institute (EPRI), the National Association of Regulatory Utility Commissioners (NARUC), PJM Interconnection, industry, and interested members of the public at the Hyatt Regency Hotel in Bethesda, MD to discuss the draft Grid Reliability Generic Letter (GL). The staff discussed the purpose of the questions in the GL, staff expectations for the licensee's response to the GL, and how the information gathered by the GL will be utilized. The staff will consider the stakeholders' questions and comments on the draft GL that were provided at the workshop before issuing the final GL.

Issuance of Notice Providing the Staff's Proposed Determination of No Significant Hazards Consideration Related to Vermont Yankee's Extended Power Uprate Amendment Request

On January 5, 2006, the NRC staff issued a letter to Entergy, the licensee for the Vermont Yankee Nuclear Power plant, which provided the subject notice. The Notice provides the NRC's proposed determination that the EPU amendment request involves no significant hazards consideration (NSHC) in accordance with 10 CFR 50.92. The NRC published the Notice in the Federal Register on January 11, 2006. The comment period for this action closes 30 days after publication.

Waste Determination for the Idaho Nuclear Technology and Engineering Center Tank Farm Facility (Idaho TFF)

On January 10, 2006, staff from the Division of Waste Management and Environmental Protection transmitted a Request for Additional Information (RAI) to the U.S. Department of Energy (DOE) regarding its Section 3116 Determination for the Idaho TFF. The RAI was issued as part of NRC's review in accordance with the National Defense Authorization Act of FY 2005, which requires DOE to consult with NRC on its incidental waste determinations in Idaho and South Carolina.

Staff Observes DOE Audit of the U.S. Geological Survey (USGS) Program

On January 9-12, 2006, staff observed a DOE audit of the quality assurance (QA) program implementation at USGS in Denver, CO. The audit reviewed the adequacy, implementation, and effectiveness of the QA program procedures applicable to the USGS scope of work in support of the Yucca Mountain project.

On January 10, 2006, Region I and Region III staff members met with representatives of FirstEnergy Nuclear Operating Co. at the Beaver Valley Nuclear Power Station to discuss the performance of the three FirstEnergy facilities – Beaver Valley, Davis-Besse, and Perry.

Special Inspection at Quad Cities

Region III initiated a special inspection on January 9, 2006, at the Quad Cities Nuclear Power Station to review the circumstances surrounding the degradation of electromagnetic relief valve actuations for both Units 1 and 2. The inspectors continue to review the licensee's root cause determination and corrective actions.
