PURPOSE: The U.S. NRC Office of Nuclear Regulatory Research (RES) in

conjunction with the Electric Power Research Institute (EPRI) will hold a second public workshop on Fire Probabilistic Risk Assessment (PRA). Since 2002, RES and EPRI under a Memorandum of Understanding (MOU) on Cooperative Nuclear Safety Research have been developing state-of-the-art methods for conduct of fire PRA. In September 2005, this work produced the "EPRI/NRC-RES Fire PRA Methodology for Nuclear Power Facilities," NUREG/CR-6850 and EPRI 1011989. This report addressed public comments, and received favorable review by the Advisory Committee for Reactor Safeguards (ACRS). The workshop
