Dear Mr. Seeley:

On December 23, 2005, Koch Forest Products, Inc. (KFP), a wholly-owned subsidiary of Koch Industries, Incorporated, completed its purchase of the outstanding shares of Georgia Pacific Corporation (Georgia-Pacific). KFP and Georgia Pacific have now merged, with Georgia Pacific as the surviving entity. Prior to this transaction Georgia-Pacific was a publicly held corporation. With the completion of this transaction Georgia-Pacific is now a privately held, wholly owned subsidiary of Koch Industries, Incorporated.

We are writing to inform you of the completion of this transaction and to advise that the direct ownership of our facility by Georgia-Pacific Corporation, is unchanged by this transaction, and that we intend to continue operating under the name listed on our environmental permit(s). As such, we do not believe it is necessary to modify or change the permit(s) listed above for our facility.
