Mr. Lawyer,

In response to our phone discussion earlier today, here is a clarification to the Facility History of the Radiological Characterization of Building 747 contained in the Request for Additional Information Response dated January 27, 2006.

The last sentence of the first paragraph is inaccurate. It should have read as originally stated. "However, work involving loose isotopes would have been conducted in this building".

We used tritium and carbon 14 in loose form for analytical work in Building 747. Samples were stored in the adjacent Radiation Shed. Both buildings were thoroughly wipe-tested for residual contamination. The results indicate no evidence of any radioactive contamination. This is further described in the Radiological Characterization of Building 747.
