

The purpose of this modification is to:

- (1) revise subsection A.2 CONSIDERATION AND OBLIGATION to provide incremental funding in the amount of \$31,000.00, thereby increasing the obligated amount from \$6,283,980.87 to \$6,314,980.87.

Accordingly, the task order is modified as follows:

1. Under Subsection A.2 CONSIDERATION AND OBLIGATION, increase the obligated amount by **\$31,000.00**, from \$6,283,980.87 to **\$6,314,980.87**. Therefore, the first sentence of paragraph (b) is deleted entirely and the following is substituted in-lieu thereof:

“...(b) The amount presently obligated with respect to this contract is **\$6,314,980.87**.”
