The Fuel Cycle Facilities Branch requests technical assistance in reviewing the following project:

Project: Sequoyah Fuels Corporation (SFC) amendment request to approve its proposed reclamation plan

TAC No.: L52511; fee recoverable

Docket No.: 40-8027

Requested Action: Provide a review of the radiation protection aspects of SFC's proposed reclamation plan for its facility in Gore, Oklahoma. The staff reviewed the reclamation plan and prepared a Draft Safety Evaluation Report (DSER) in September 2005. The DSER identified 8 open issues and 4 confirmatory items related to radiation protection. SFC has recently responded to the DSER, addressing the open issues and confirmatory items and revising portions of the reclamation plan. Assistance from your directorate is requested to review licensee's responses and the revised reclamation plan. Your support should include a review of the radiation protection responses and revisions to the reclamation plan, discussions with the licensee as needed, and input to the staff's final SER.
