It has come to our attention that the acceptance version of the NEDE-32906P, Revision 0 was never submitted to the Nuclear Regulatory Commission. The NEDE-32906P-A Revision 1 dated April 2003 and NEDO-32906-A Revision 1 dated June 2003 were prepared and released but were apparently not formally transmitted to the NRC. This letter submits NEDE-32906P-A, Revision 1 (with a current affidavit) along with the companion Non-Proprietary version NEDO-32906-A.

Enclosure 1 (CD-ROM labeled GE Proprietary Information) contains three files: (1) this letter, (2) the affidavit, and (3) the proprietary version of Revision 2. Enclosure 2 is a non-proprietary version of Revision 2. Enclosure 3 contains the original affidavit.

Please note that Enclosure 1 contains proprietary information of the type that GE maintains in confidence and withholds from public disclosure. The information has been handled and classified as proprietary to GE as indicated in the affidavit, also included in the report. The affidavit contained in Enclosure 3 identifies that the information contained in Enclosure 1 has been handled and classified as proprietary to GE.
