In accordance with your request [reference a:] and pursuant to RH 3.24 of the State of Colorado *Rules and Regulations Pertaining to Radiation Control*, you are hereby authorized to use radioactive materials in CO. This authorization is valid on January 9, 2006 through February 15, 2006. This authorization is valid on the date and location specified above, and only at temporary job sites in CO that are not under exclusive federal jurisdiction. Such use shall be conducted accordance with the Colorado Regulations (RH 3.24) and your *Radioactive Materials License* [reference b:].

You are required to notify our office in writing at least three (3) days prior to each use of radioactive material in Colorado. Further, you must notify the Department within one (1) hour after arrival at the actual work location within the State, and notify the Department within one (1) hour after any change in work location within the State.

Please note you may be subject to a routine inspection.

Special Condition(s). The following must be in the possession of the users at the work site: (1) a copy of the State of Colorado *Rules and Regulations Pertaining to Radiation Control*; (2) a copy of the *Radioactive Materials License*; (3) a complete inventory of sources brought into the State; (4) pertinent U.S.D.O.T documents; (5) leak test records for sources brought into the State; (6) instrument calibration records; and (7) personnel training records.
