SUBJECT: REQUEST FOR HEMATITE LOCAL PUBLIC DOCUMENT ROOM

This is in response to your memorandum to Jona L. Souder, dated August 10, 1992, requesting the establishment of a local public document room (LPDR) for the Combustion Engineering, Inc. facility in Hematite, MO.

The decision has been made to set up a LPDR for Docket No. 70-36. I was informed by Sean Soong that the LPDR should remain operational at least six months after the license is renewed. At that time we will reevaluate the need for this LPDR.

I have officially requested, in a memorandum dated August 20, 1992, that the Document Control Branch, IRM, provide us with copies of all publicly available documents for this docket. We should start receiving this material on a routine basis. However, we will need NMSS to provide us with copies of the pre-September 1992 documents that need to be placed into the LPDR.

We suggest that any of the documents that have not been processed through NUDOCS be put through the system.

For your information, I have attached a copy of the Federal Register Notice which states our intent to establish this LPDR. We anticipate that this notice will be published sometime next week.

Among the factors the NRC will consider in selecting a location for the collection are:


- (1) Whether the institution is an established document repository with a history of impartially serving the public;
- (2) The physical facilities available, including shelf space, patron work space, and copying and micrographic equipment;
- (3) The willingness and ability of the library staff to maintain the LPDR collection and assist the public in locating records;
- (4) The public accessibility of the library, including parking, ground transportation, and hours of operation, particularly evening and weekend hours;

- (5) The accessibility of the library to the handicapped;
- (6) The proximity of the library to the Combustion Engineering, Inc. facility located in Hematite, Missouri;

Public comments are requested on libraries in the vicinity of the Hematite, Missouri, facility that might be considered for selection as the location for this NRC local public document room collection.



This is in response to your letter dated June 28, 1992, (postmarked May 29, 1992), to Jona Souder, LPDR Program Manager, requesting that we establish a local public document room (LPDR) for the Combustion Engineering, Inc. (CE) facility located in Hematite, Missouri.
