Dear Mr. Bell:

In accordance with your correspondence dated February 16, 2001, and supplement dated April 5, 2001, and pursuant to Part 70 to Title 10 of the Code of Federal Regulations, Materials License SNM-33 is hereby amended to replace the former licensee name, CE Nuclear Power LLC, with the licensee's new name, Westinghouse Electric Company LLC. Accordingly, Condition 1 of the license has been revised to read "Westinghouse Electric Company LLC." All other conditions of this license shall remain the same.

Please be advised that the revised decommissioning cost estimate, and executed standby letter of credit and standby trust agreement, submitted with your letters dated March 6, and 27, 2001, remain under review as a separate matter. Until such time as U.S. Nuclear Regulatory Commission (NRC) approves alternative financial assurance for decommissioning, the current guarantee remains in effect.

Enclosed are copies of the amended Materials License SNM-33 and the Safety Evaluation Report, which includes the Categorical Exclusion.
