SUBJECT: SUMMARY OF THE JANUARY 25, 2006, CATEGORY 1 MEETING WITH UNISTAR - CONSTELLATION ENERGY TO DISCUSS PLANS FOR A CONSTELLATION COMBINED LICENSE APPLICATION

On January 25, 2006, a public meeting was held between the U.S. Nuclear Regulatory Commission (NRC) and representatives of UniStar - Constellation Energy, at the NRC Headquarters in Rockville, MD. The purpose of the meeting was for UniStar - Constellation Energy to share with the NRC its future plans for a combined license (COL). A list of meeting attendees is included as Attachment 1, and the agenda is included as Attachment 2. Attachment 3 contains UniStar - Constellation's meeting handout which can be accessed through the Agencywide Documents Access and Management System (ADAMS). This system provides text and image files of NRC's public documents. The handout mentioned above may be accessed through the ADAMS system under Accession No. ML060380172. A summary of the meeting is included below.

UniStar started the meeting by discussing their plans for using the United States Evolutionary Power Reactor (EPR) design at Constellation sites, as well as, discussions with other licensees looking for a new reactor design. They introduced the UniStar team along with the division of responsibilities among Constellation Energy, Framatome ANP, and Bechtel. UniStar discussed their philosophy for early resolution of issues, and standardization of the COL applications which will be referencing the EPR design. The NRC staff and UniStar discussed plans for submission of information necessary to allow for approval of a limited work authorization. UniStar discussed their schedule for performing site characterization activities at Calvert Cliffs, one of several potential UniStar sites, starting March 27, 2006. UniStar is scheduled to start submitting early COL section starting in January 2007, and the entire COL application by June 2008.
