## MEETING SUMMARY

Licensee: Pennsylvania Department of Environmental Protection (PADEP)  
Facility: Quehanna Site  
Subject: SUMMARY OF JANUARY 25, 2006 MEETING BETWEEN NRC AND PADEP

On January 25, 2006, at 10:00 am at the Rachel Carson State Office Building in Harrisburg, PA, a meeting between the Nuclear Regulatory Commission (NRC) and PADEP took place. The meeting was held at the request of PADEP in order to discuss the path forward for completion of decommissioning activities at the Quehanna Site located near Karthaus, PA.

The meeting opened with introductions, and PADEP then presented a recap of the Quehanna decommissioning project to date and plans for demolition of the on-site buildings to grade level. After discussions regarding the building demolition and the radiological criteria to be utilized for release of the demolition debris, PADEP presented their plans for submittal of a revision to the Decommissioning Plan (DP). Discussions after this presentation centered on the dose assessment and subsequent derivation of Derived Concentration Guideline Limits (DCGLs) that PADEP would include in their revision to the DP in order to demonstrate that the Quehanna Site would meet the NRC criteria for unrestricted release.

A presentation was also made at the meeting by the Pennsylvania Department of Conservation and Natural Resources (PADCNR). The Quehanna Site is located within the Quehanna Wild Area of the Moshannon State Forest. PADCNR's presentation indicated that after decommissioning of the Quehanna Site was completed, the site would be returned to its natural, wild state and become a part of the Quehanna Wild Area.

The meeting concluded with PADEP presenting their planned schedule for submittal of license amendment requests for a work plan for building demolition and a revision to the DP.

The location selected for the meeting was intended to provide an opportunity for public attendance and participation. No members of the public attended this meeting.
