Dear Ms. Fisher:

By letter dated August 19, 1996, as supplemented April 8, 1997, Public Service Company of Colorado (PSCo) submitted its response to U.S. Nuclear Regulatory Commission Bulletin 96-04, "Chemical, Galvanic or Other Reactions in Spent Fuel Storage and Transportation Casks," for the Fort St. Vrain (FSV) Independent Spent Fuel Storage Installation (ISFSI). The NRC staff has reviewed the PSCo response to the bulletin for the FSV ISFSI and finds that PSCo has satisfied the requested actions of the bulletin. The staff's evaluation report is enclosed.

PSCo's submittal also addressed the transportation packages FSV-1 and TN-FSV. The staff has not evaluated the PSCo response in regard to the FSV-1 and TN-FSV packages. This evaluation will be the subject of separate correspondence.
