SUBJECT: NRC INSPECTION REPORT 72-0011/95-01

This refers to the inspection conducted by Mr. Claude E. Johnson and the personnel identified in the enclosed report on April 17-21, 1995. The inspection included a review of activities related to the construction of an independent spent fuel storage installation authorized for your Rancho Seco Nuclear Generating Station facility and the horizontal dry spent fuel storage modules under construction in Pleasanton, California. At the conclusion of the inspection, the findings were discussed with those members of your staff identified in the enclosed report.

Areas examined during the inspection are identified in the report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observation of activities in progress. The results of this inspection are documented in the enclosed report.

Overall, the inspector concluded that the completed roof slabs for the horizontal dry spent fuel storage modules appeared to be constructed in accordance with design drawings and specifications. Also, the concrete placement activities for the independent spent fuel storage installation were generally in accordance with site specifications. However, this inspection identified weaknesses in quality assurance activities. We understand from discussions with your staff during a pre-exit meeting on April 19, 1995, that these weaknesses would be reviewed and corrected.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter and its enclosures will be placed in the NRC Public Document Room.


