Shipment one contains 40 fuel assemblies in 20 sealed NT-IV shipping containers, loaded onto five flatracks and containing approximately 6,840 kgU at an average enrichment of approximately 3.80 wt% U-235, based on the design weights. Shipment two contains 92 fuel assemblies in 46 sealed NT-IV shipping containers, loaded onto twelve flatracks and containing approximately 15,731 kgU at an average enrichment of approximately 3.80 wt% U-235, based on the design weights.

## 3. Transport Route

Shipment one will depart from Oakland, CA via the vessel "NYK Lynx" going to Tokyo, Japan. Shipment two will depart from Oakland, CA via the vessel "NYK Lodestar" also going to Tokyo, Japan.
