In accordance with 10 CFR 50.54, "Conditions of licenses," paragraph (p)(2), AmerGen Energy Company, LLC (AmerGen) is submitting Revisions 3 and 4 to the Oyster Creek Generating Station Security Plan. The changes to the Oyster Creek Generating Station Security Plan, Training and Qualification Plan, and Safeguards Contingency Plan were implemented on December 30, 2005, for Revision 3 and January 27, 2006, for Revision 4. In accordance with 10 CFR 50.54(p)(2), AmerGen is submitting these changes within 60 days of implementation (i.e., March 1, 2006, for Revision 3 and March 28, 2006, for Revision 4). A summary of the revisions to the Oyster Creek Generating Station Security Plan, Training and Qualification Plan, and Safeguards Contingency Plan are provided below.

Revision 3

The Security Plan, Training and Qualification Plan, and Safeguards Contingency Plan have been revised to increase the commitment and further clarify the compensatory measures required for the failure or degradation of the vehicle barrier system. These changes are being made based on NRC staff recommendations contained in Security Frequently Asked Question (SFAQ) 04-09 approved on June 30, 2005.

Revision 4

The Security Plan, Training and Qualification Plan, and Safeguards Contingency Plan have been revised to increase the minimum number of armed responders that are immediately available to implement the site's protective strategy.

AmerGen has concluded that the changes contained within Revisions 3 and 4 do not decrease the safeguards effectiveness of the Oyster Creek Generating Station Security Plan, Training and Qualification Plan, and Safeguards Contingency Plan.
