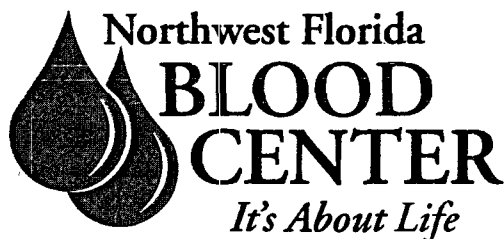

On behalf of The Northwest Florida Blood Center I am requesting an import licensure for delivery of a Gammacell 3000 irradiator. Our facility ordered the irradiator in August 2005 from MDS Nordion. Their address is 447 March Road, Ottawa, Ontario, Canada K2K 1X8. The irradiator has a cesium-137 solid, sealed source with an approximate cost of [REDACTED]. With U.S. Nuclear Regulatory Commission's permission, we have set a tentative delivery date of [REDACTED].
