


A. 49 CFR 172.704(c)(2) requires that a hazmat employee shall receive the training required by this subpart at least once every three years. Contrary to the above on 2/7/06 a hazmat employee transported a portable gauge and his training as required had been given last on December 2001, greater than three years ago. The licensee will arrange for a hazmat training class in the near future.

B. 10 CFR 30.34 requires that each portable gauge licensee shall use a minimum of two independent physical controls that form tangible barriers to secure portable gauges from unauthorized removal, when even portable gauges are not under the control and constant surveillance of the licensee. The licensee has stored portable gauges in personal vehicles with only one physical control that forms a tangible barrier. The licensee will arrange each transport vehicle and implement two independent physical controls that form tangible barriers when the gauge is not under the control and

Licensee's Statement of Corrective Actions for Item 4, above.

I hereby state that, within 30 days, the actions described by me to the inspector will be taken to correct the violations identified. This statement of corrective actions is made in accordance with the requirements of 10 CFR 2.201 (corrective steps already taken, corrective steps which will be taken, date when full compliance will be achieved).
