Dear Ms. Parr:

We have performed an initial review of your 2005 Westinghouse 10 CFR 70.72 Facility Change Report dated January 19, 2006 (WEC Ref. LTR-RAC-06-5). Based on this review, we have determined that the submittal does not meet the requirements of 10 CFR 70.72 (d)(2), since it does not include a brief summary of the changes. Specifically, the submittal must be modified to include, for each change, an explanation of the change, the reason why the change was made, and why the change did not require pre-approval. Please provide the requested revisions within 30 days from the date of receipt of this letter.

Also, we will review both your internally authorized changes and your 2005 Integrated Safety Analysis summary updates, as part of the same action, so we have combined both reviews into TAC L31925. Please reference this TAC number in any future correspondence associated with these actions.
