SUBJECT: COMPLETION OF ACTIONS SET FORTH IN CONFIRMATORY ORDER

Dear Mr. Guariglia:

The purpose of this letter is to acknowledge receipt of your letter dated January 27, 2006, in which you documented completion of actions you were required to perform in accordance with the Notice of Violation and Confirmatory Order issued to you by the U.S. Nuclear Regulatory Commission (NRC) on August 18, 2005. Those actions included the following: (a) writing an article to share with the Constellation fleet that explains the importance of following procedural requirements, maintaining the integrity of unannounced fire drills, and maintaining a questioning attitude to verify and validate decisions; (b) participating in a stand-down meeting with the appropriate fire protection staff prior to December 31, 2005, and describing the lessons learned from the compromised fire drill and the importance of raising concerns when an issue does not comply with requirements; and (c) notifying the NRC, in writing, within 30 days of completion of the actions described above.

In your January 27, 2006, letter you included a copy of the article written entitled, "The Importance of Procedure Compliance," as well as proof of fire brigade briefings to appropriate personnel. The NRC has reviewed your actions and plans no further action regarding this matter.

In accordance with the agreement reached at the Alternative Dispute Resolution (ADR) session, a copy of this letter will be made available electronically for public inspection in the NRC Public Document Room or from the NRC's document system (ADAMS). ADAMS is accessible from the NRC Web site at <http://www.nrc.gov/reading-rm/adams.html>. Your January 27, 2006, response, with your address removed, will also be made available electronically for public inspection in the NRC Public Document Room or from the NRC's document system (ADAMS).
