This is in reference to your financial assurance which is secured through a Statement Of Intent. Guidance regarding the Statement of Intent is found in NUREG - 1757, Volume 3, 'Consolidated NMSS Decommissioning Guidance'. The guidance states that the person signing the Statement of Intent must provide documentation that he or she is authorized to represent the licensee for that transaction. The authority should originate in a statute authorizing the head of the agency, department or institution to request funds. During a recent audit of our financial assurance files we found that we did not have this documentation for your Statement of Intent. Please provide documentation demonstrating that the individual who signed your Statement of Intent has the authority to request funding for decommissioning activities.
