Dear Mr. Rainey:

This is in reference to your letter dated January 23, 2006 requesting to amend Nuclear Regulatory Commission License No. 37-30489-01. In order to continue our review, we need the following additional information:

1. In your letter dated January 23, 2006, you requested to name Mr. Henry E. Schea as the new Radiation Safety Officer (RSO) for your self-shielded irradiator licensed activities. RSOs must have adequate training and experience. Successful completion of training described in Appendix G of NUREG-1556, Volume 5 "Consolidated Guidance About Materials Licenses: Program Specific Guidance About Self-shielded Irradiator Licenses" is evidence of adequate training and experience. Please demonstrate that Mr. Schea has equivalent training and experience.
2. Please provide Mr. Schea's business email address for our records.
