The County of Fairfax, Virginia and the Noman M. Cole, Jr., Pollution Control Plant, holder of License No. 45-19479-01 is reporting.

Unit No. B-104, Model TN 5034 was removed by the Jendco Corp. of Pittsburgh, Pennsylvania, on October 8, 2004., and was in the possession of AEA Technology, Baton Rouge, Louisiana, as of October 12, 2004. Unit No. B-100, Model TN 5034, was removed by the Jendco Corp. of Pittsburgh, Pennsylvania, on January 18, 2006, and was in the possession of AEA Technology, Baton Rouge, Louisiana, as of January 25, 2006. This information is included as attachments number 1 and 2.

The Noman M. Cole facility is anticipating the removal of the remaining five TN model 5034 units (density gauges) during the year 2006. Will this require additional requests for license amendments? Please advise.


