


Subject Delegation of Authority for Radiation Safety Officer

To CFSAN Management Council

The CFSAN Nuclear Regulatory Commission Materials License was renewed on September 6, 2005. The Center is authorized to possess by-product material for research and development as defined in 10 CFR 30.4, to include animal studies.

Ms. Constance Rosser will continue to serve as the CFSAN Radiation Safety Officer whose responsibility is to ensure the safe use of radioactive material. She will be responsible for managing the radiation safety program; identifying radiation safety problems; initiating, recommending or providing corrective actions; and ensuring compliance with regulations for the use of radioactive material. Ms. Rosser is hereby delegated the authority necessary to meet these responsibilities.

Ms. Rosser has the authority to immediately stop any operations involving the use of by-product material in which health and safety may be compromised or may result in non-compliance with Nuclear Regulatory Commission requirements.
