Dear Mr. Reichard:

Per your request from an email dated February 22, 2006, the following is the information you requested to finish processing our application for a radioactive material license.

Prior to using the licensed materials, authorized users will have completed a nuclear gauge safety training class and a hazardous materials course conducted by certified personnel which is often the gauge manufacturer such as "Troxler Electronic Laboratories, Inc." The nuclear gauge safety training course topics include radiation safety fundamentals and principles, regulatory requirements, portable gauge theory, design, and operation, gauge maintenance and transportation procedures, leak testing, and storing, packing, and transporting gauges. An examination is required to complete the course and obtain a certification. To pass the examination, a score of at least 70 percent is required on a 25 to 50 question exam. In addition to the course, each user of the gauge will be familiarized with our current emergency response procedures as well as our handling and storage techniques.

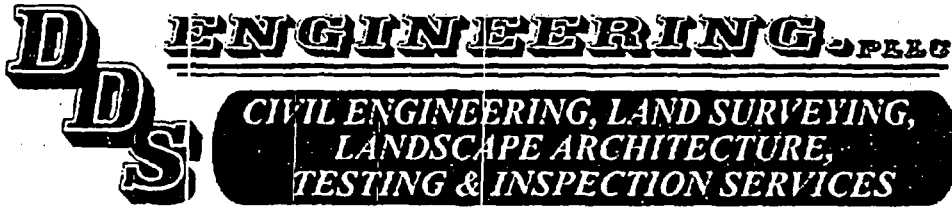


