

The purpose of this modification is to 1) exercise Option Year Two of the contract, thereby increasing the ceiling amount of the contract by \$110,000.00, from \$258,800.00 to \$368,800.00; 2) increasing the amount obligated in the contract by \$110,000.00 from \$234,413.00 to \$344,413.00; and 3) extend the period of performance of the contract from February 19, 2006 through February 18, 2007. Accordingly, the contract is hereby modified as follows:

1. Section B, Subsection B.5 CONSIDERATION AND OBLIGATION, paragraph (a), first sentence, is deleted in its entirety and substituted with the following in lieu thereof:

"The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$368,800.00."

2. Section B, Subsection B.5 CONSIDERATION AND OBLIGATION, paragraph (b), first sentence, is deleted in its entirety and substituted with the following in lieu thereof:

"The amount presently obligated with respect to this contract is \$344,413.00."

3. Section B, Subsection B.8 DESCRIPTION/SPECIFICATIONS/WORK STATEMENT, paragraph IX, PERIOD OF PERFORMANCE, is deleted in its entirety and substituted with the following thereof:

"The period of performance of this contract is February 19, 2006 through February 18, 2007."

A summary of obligations under this contract, from the date of award through the date of this action, is provided:

TOTAL FY'04 OBLIGATIONS:	\$134,413.00
TOTAL FY'05 OBLIGATIONS:	\$100,000.00
TOTAL FY'06 OBLIGATIONS:	\$110,000.00

CUMULATIVE TOTAL OF NRC OBLIGATIONS: \$344,413.00

This modification obligates fiscal year 2006 funds in the amount of \$110,000.00.

All other terms and conditions of the subject contract remain unchanged.
