The purpose of this modification is to:

- (1) extend the period of performance of the subject task order through June 30, 2006 at no additional cost to the Government, per your email request dated 1/12/2006;
- (2) revise the Statement of Work (SOW) to delete the Adobe LiveCycle Designer 7.0 and Adobe Document Server 6.0 for Reader Extensions software maintenance, which was incorrectly included in the SOW, but is not being procured under the task order;
- (3) change the NRC Project Officer from Gene Wood to Tyrone Greene.

Accordingly, the subject task order is hereby modified as follows:

1. The period of performance reflected under Item 17. SCHEDULE of the task order's Optional Form 347 – ORDER FOR SUPPLIES OR SERVICES, is DELETED entirely and REPLACED with the following:

"PERIOD OF PERFORMANCE: 10/03/2005 – 06/30/2006."
2. Section C.3., Objectives, of the Statement of Work is DELETED entirely, and REPLACED with the following:

"C.3. Objectives

The objectives of this project are to convert our current forms to Adobe Portable Document Format (PDF) fillable forms, provide necessary training so that in-house staff can create future forms, develop a front-end Web page for easy NRC staff access to available forms, and provide an on-line training module."
3. The last sentence under Section C.4., Scope of Work, of the SOW, which starts with "*The Contractor shall provide Adobe LiveCycle Designer 7.0 and Adobe Document Server 6.0 for Reader Extensions vendor software maintenance...*," is DELETED entirely.
4. Section C.5.8., Maintenance, of the SOW is DELETED in its entirety.

5. Under Section C.6.2., Submission of Deliverables, of the SOW, the NRC Project Officer's name, and delivery and email addresses are revised to read as follows:
