

The purpose of this modification is to provide incremental funding in the amount of **\$5,521,400.00**, thereby increasing the obligated amount of the task order from \$49,008,620.82 to **\$54,530,020.82**;

Accordingly, the following section of the task order is hereby modified:

"(b) The amount presently obligated with respect to this task order is **54,530,020.82**."
