

The purpose of this modification is to:

- (1) Provide incremental funding in the amount of \$445,600.00, thereby increasing the total obligated amount of the task order from \$100,000.00 to **\$545,600.00**.

Accordingly, the subject task order is modified as follows:

- 1. Under Section **14.0 CONSIDERATION AND OBLIGATION**, paragraph (a) is DELETED entirely and REPLACED with the following:

**"14.0 CONSIDERATION AND OBLIGATION**

**(a)** The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is **\$545,600.00**. The Contracting Officer may unilaterally increase this amount as necessary for orders to be placed with the contractor during the contract period provided such orders are within any maximum ordering limitation prescribed under this contract..."
