

By this award, the Recipient certifies that payment of any audit-related debt will not reduce the level of performance of any Federal Program

The purpose of this modification is to provide incremental funding in the amount of \$400,000.00 thereby increasing the obligated amount from \$1,060,000.00 to \$1,460,000.00. Accordingly, the cooperative agreement is hereby modified as follows:

“The agreement’s total obligated amount is hereby increased by \$400,000.00 from \$1,060,000.00 to \$1,460,000.00.”

A summary of obligations for this cooperative agreement, from the award date through the date of this action is provided below:

This modification obligates FY06 funds in the amount of \$400,000.00.

All other terms and conditions of the cooperative agreement remain unchanged.
