The purpose of this modification is to: 1) exercise option year two, thereby extending the period of performance and increasing the total estimated amount (ceiling) for performance of the subject contract from \$285,880.00 by \$130,816.00 to \$416,696.00, and 2) provide incremental funding in the amount of \$37,408.00.

Accordingly, the following changes are hereby made:

1. Section B.2 - Duration of Contract Period, is hereby deleted in its entirety and substituted in lieu thereof the following:

"DURATION OF CONTRACT PERIOD

The ordering period for this contract shall commence on April 14, 2004 and will expire on April 13, 2007. The term of this contract may be extended at the option of the Government for an additional two (2) one year options."

2. Section C.2 - Consideration and Obligation -- Delivery Orders (JUN 1988), paragraph a. and b., first sentence is hereby deleted in its entirety and the following is substituted in lieu thereof the following:

"a. The total estimated amount of this contract (ceiling) for products/services ordered, delivered, and accepted under this contract is \$218,696.00. "

"b. The amount presently obligated with respect to this contract is \$109,348.00."

3. Section C.3 - Consideration and Obligation - Task Orders (AU 1989), paragraph a., first sentence is hereby deleted in its entirety and the following is substituted in lieu thereof the following:

"a. The total estimated amount of this contract (ceiling) for the products/serviced ordered, delivered, and accepted under this contract is \$198,000.00."
