

The purpose of this modification is to: 1) exercise option year four of the contract in accordance with Subsection C.10, FAR Clause 52.217-9, entitled, "Option to Extend the Term of the Contract," 2) provide incremental funding in the amount of \$45,100, and 3) modify Subsection B.12, entitled, "PERIOD OF PERFORMANCE," thereby extending the contract period of performance through June 30, 2007. As a result of this action, the ceiling amount of the contract is hereby increased by \$97,580 from \$409,800.00 to \$507,380.00 and the obligated amount is increase by \$45,100.00 from \$125,200.00 to \$170,300.00.

Accordingly, the contract is hereby modified as follows:

1. Subsection B.12, PERIOD OF PERFORMANCE, is deleted in its entirety and substituted with the following in lieu thereof:

**"B.12 PERIOD OF PERFORMANCE**

The period of performance of this contract shall be from July 1, 2002 through June 30, 2007."

2. Under Subsection C.12, Consideration and Obligation - Delivery Orders, the first sentences of Paragraph (a) is deleted in its entirety and substituted with the following in lieu thereof:

"(a) The total estimated amount of this contract (ceiling) for the products/services, ordered, delivered and accepted under this contract is \$507,380.00."

2. Under Subsection C.12, Consideration and Obligation - Delivery Orders, the first sentences of Paragraph (b) is deleted in its entirety and substituted with the following in lieu thereof:

"(b) The amount presently obligated with respect to this contract is \$170,300.00."
