


Confirming the verbal authorization provided to the University of Maryland on 10/25/05, the purpose of this bilateral modification is to: (1) Increase the estimated ceiling amount of this contract by \$97,575, from \$456,244 to \$553,819, (2) increase the obligated amount by \$97,575 from \$456,244 to \$553,819 and (3) extend the period of performance through July 31, 2006. Accordingly, the contract is hereby modified as follows:

1. Section B.3, Consideration and Obligation-Cost Reimbursement (JUN 1988) Alternate I (JUN 1988) paragraph (a) is deleted in its entirety and the following paragraph is substituted in lieu thereof:

"The total estimated cost to the Government for full performance under this contract is \$553,819."

2. Section B.3, Consideration and Obligation-Cost Reimbursement (JUN 1988) Alternate I (JUN 1988) paragraph (b) is deleted in its entirety and the following paragraph is substituted in lieu thereof:

"b. The amount presently obligated by the Government with respect to this contract is \$553,819 which fully funds this contract."

3. Section F.6 Duration of Contract Period (MAR 1987) is deleted in its entirety and the following sentence is substituted in lieu thereof:

"This contract shall commence on the award date and will expire on July 31, 2006."

All other terms and conditions of the contract remain unchanged.

A summary of obligations for this contract from the date of award through the date of this action is provided below:
