The purpose of this contract modification is to: 1) exercise Option Year Two to extend the term of the contract from April 5, 2006, to April 4, 2007; 2) change the Project Officer designation in the contract; and 3) increase the funding in the contract by \$56,960.00, from \$105,520.00 to \$162,480.00. Accordingly, the contract is modified as follows:

1. Section B.4, paragraph (a) and (b), first sentences, as modified in Modification No. 4, are deleted and substituted with the following in lieu thereof:

“(a) The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$224,950.00.”

2. Section F.4, as modified in Modification No. 4 is deleted and substituted with the following in lieu thereof:

“The ordering period for this contract shall commence on April 5, 2004 and will expire on April 4, 2007. Any orders placed on the term of this contract may be extended at the option of the Government for an additional two one-year periods.”

3. Section G.1 2052.215-71, “Project Officer Authority-Alternate 2, paragraph (a) is hereby deleted in its entirety and replaced with the following:
