


The purpose of this modification is to (1) exercise Option Period Three in accordance with Section A.2, FAR 52.217-9 "Option to Extend the Term of the Contract", thereby extending the period of performance through March 4, 2007, (2) increase the contract ceiling amount by \$429,441.52 from \$1,222,222.00 to \$1,651,663.52, (3) provide incremental funding in the amount of \$429,441.52 which increases the obligated amount from \$1,222,222.00 to \$1,651,663.52. Accordingly the contract is modified as follows:
